**Form 990, Part VI, Section B, Line 12c - Funding Arts Broward requires all volunteer members prior to reviewing grant applications to disclose any potential conflicts of interest. If a conflict of interest exist, the volunteer will be assigned to a different group of applications to be screened. Each board members is required to sign a conflict of interest agreement each year and is required to notify the organization if a conflict presents itself.**
